

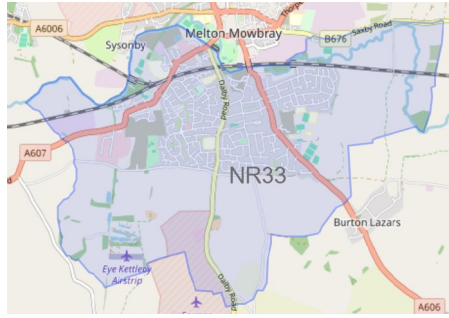

#YouSaid - What matters to you

We have listened to you and the concerns you raised and the following:

You said: Drug users / dealing, and the crime associated with it are causing you concern.

What we are going to do: Whilst we will robustly deal with those who break the law, we will also seek to engage with the drug users in order to understand what factors are driving them to this lifestyle and what interventions we can offer.

You Said: Anti-social behaviour is causing you a concern.

What we are going to do: Identify those that are responsible and deal with them accordingly via the ASB incremental approach.

You said: Speeding and road safety on the beat is a concern for you.

Community Engagement

Traffic Enforcement

- A vehicle reported for driving without documentation was **seized**, and the driver received a **Traffic Offence Report (TOR)** for having no insurance.

A very good spot by PCSO Sal!



Anti-Social Behaviour

- A resident was visited again by the beat team, the housing association officer and an officer from the Community Safety Team from Melton Borough Council due to ongoing **cannabis smell complaints**. They agreed to an **Acceptable Behaviour Contract (ABC)** which will stay in place for the next 3 months. An ABC is a voluntary agreement used to address anti-social behaviour. While not legal binding, it can be used as evidence in court if the behaviour continues.
 - Another address received a **warning** for similar cannabis-related issues.
- Cannabis remains a class B drug, and possession is an offence.
- High-visibility **foot patrols** were conducted in hotspot areas.

□ Crime & Patrols

- A **male was interviewed** for misuse of a public communication network.
- We have been supporting our response teams with **live incidents** throughout June too and completing high visible patrols often on foot in some of our hotspot areas.

Teamwork with other beat officers from our neighbouring beats, assisting them with visiting vulnerable persons, dealing with suspects of criminal activity and on-going neighbour disputes.

□ Safeguarding & Welfare

Officers responded to **mental health-related welfare concerns**, including submitting a **safeguarding report** with the individual's consent.

□ Station Duties

- The team also supported the **front enquiry office**, handling a wide range of public enquiries including criminal reports, intelligence sharing, and general queries.

- We continue to deal with local issues such as Anti-social behaviour and safeguard vulnerable residents and cuckooing victims as and when we identify concerns.
- Our work is ongoing with local schools including engagement events.
- And lastly as 'Dedicated Neighbourhood Officers' we continue to work on and try find solutions with neighbour disputes. We also support our response colleagues and cover the front enquiry office too.
