

## #YouSaid - What matters to you

### Priority 1: Drug Dealing

*You said:* Issues re drug dealing in the local community.

*What we are going to do:* Patrols are taking place throughout the day and night and stop search powers are being utilised where grounds permit. Anyone found with illegal substances on them are being dealt with accordingly. Further patrols are also taking place throughout hot spot areas to build up intelligence that can be acted on. Please continue to report any suspicious activity to us.

### Priority 2: Road Safety

*You said:* Speeding and road safety on the beat is a concern for you.

*What we are going to do:* Patrols will take place in locations identified where vehicles are being used to cause harassment, alarm or distress. Section 59 powers will be utilised to take action against drivers who are causing anti social behaviour. Speed enforcement operations will be carried out across the beat to deal with those that speed excessively.

### Priority 3: Anti-social Behaviour

*You Said:* Concerns raised relating to youth related Anti Social Behaviour.

*What we are going to do:* Support residents on an individual basis where complaints are made, challenge those involved and work with partner agencies to implement outcomes. Complete targeted patrols where identified to disrupt and challenge behaviour. These issues can occur anywhere, so we rely on your communication to tackle these issues.

### Town North Beat Newsletter – January Update

It has been a busy and productive month for the **NR32 Town North Beat Team**, with significant proactive work carried out to tackle drug-related crime, anti-social behaviour, and wider community concerns.

## #WeDid—What we are doing continued

### Major Drug Warrants Executed

Over the past month, the team has executed a number of warrants targeting individuals suspected of drug dealing in the local area.

During one warrant, **two people were arrested** on suspicion of **Possession with Intent to Supply Class A and Class B drugs**. A thorough search of the address uncovered a **large quantity of Class A controlled substances**, later confirmed as **heroin and crack cocaine**.

- **Initial estimated street value:** over **£14,000**
- **Expected total value once all exhibits are tested:** approximately **£30,000**

This represents a substantial disruption to local drug supply, and investigations remain ongoing.

### Proactive Stop Checks

PC O'Rourke, supported by **PC 4410 from the Melton South Beat**, has been conducting several vehicle and person stop checks, leading to positive outcomes for the community.

### Community Resolution Issued

One stop check resulted in a passenger being found in possession of **Class B drugs**. The individual was dealt with by way of a **community resolution**.

### Arrests Following Foot Chase

In another incident, PC 2170 and PC 4410 stopped a vehicle where the passenger attempted to flee. He was later located, and suspected **Class A drugs** were recovered nearby.

- **Both the passenger and driver were arrested** for possession of Class A drugs.
- The driver also **failed a roadside drugs wipe** and was further arrested for **driving whilst unfit through drugs**.

### New Officer Making an Early Impact

PC **Jacob Gill**, who recently joined the beat team, has already been making a positive difference. Jacob has carried out several stop checks and recently **seized a vehicle that had been untaxed for a significant period of time**.

PCSO **Durrant** is also making a **strong and positive impact** on the beat. He has been actively **patrolling local hot spot locations**, engaging with residents, listening to concerns, and helping build strong relationships within the community.

## Continued

### Tackling Anti-Social Behaviour

The beat team continues its efforts to address **anti-social behaviour** across the area. Offenders are being issued with **Community Protection Warnings (CPWs)** and **Community Protection Notices (CPNs)**. A breach of a CPN can lead to:

- **Fixed penalty fines**
- **Prosecution**

These measures help ensure the community remains safe and welcoming for all.
