#YouSaid - What matters to you

We have listened to you and the concerns you raised and will prioritise the following in **May 2025**.

Priority 1: **Anti-Social Behaviour**

You said: Issues raised relate to general anti-social behaviour and specific areas that are acting as hotspots for these individuals.

What we are going to do: Increased and targeted patrols. These patrols are focused on the hotspot areas that are causing nuisance and annoyance to residents. Stop searches have been carried out at these locations and vehicles moved on if needs be. We're continuing to patrol these hotspot areas along with our routine patrol of the Wigston area.

Priority 2: **Road Safety Issues**

You Said: Local concerns regarding road safety issues.

What we are going to do: Targeted speeding operations in problem areas, these operations are being put in place to educate motorists on the impact of increased speed, especially in a residential area. This is an ongoing project and we'll continue to tackle it. We're also tackling anti-social behaviour that's being committed using vehicles, if these vehicles are seen then words of advice are given and if that doesn't suffice then a section 59 warning may be issued.

Priority 3: **Highway Obstructions**

You said : Concerns surrounding unattended vehicles being left in an obstructive manor and debris being left on the road.

What we are going to do: Attend these locations and locate the vehicles, if they're parked in a way that blocks traffic flow or is dangerous then we'll consider removal of the vehicle. If it's not reasonable to remove the vehicle then efforts will be made to find the driver and have the vehicle moved. For debris in the road, this is mainly a council issue and they're aware of this but if there's anything new that crops up it's worth reporting it to them. If it's seen by ourselves then efforts will be made to resolve the issue.

#WeDid - What we are doing

For April crime figures were good. Officers have been working with the council to help with residents who have been experiencing anti-social behaviour at their homes, and ensuring that the best course of action is taken to suit their needs. Welfare visits have been conducted this month for vulnerable people where advice and reassurance have been given.

Summary

- Busy month for community engagement with lots of foot patrol being conducted around the Wigston area and lots of residents spoken to . If you do see any of us, come and have a chat. We're always wanting to listen to any concerns you might have.
- We have been dealing with local issues such as Anti-social Behaviour and safeguarding vulnerable residents as and when we identify concerns.
- Ongoing patrols in areas of concerns to identify those involved and reduce incidents. Some of these areas include Brighton Avenue, Brighton Close, Bell Street and Little Hill.
- Vehicles that have been used in crime and or/stolen have been taken off of the road, as well as many vehicles that do not have appropriate documentation, Tax, MOT and insurance.
- Vehicles that are also being used in an anti-social manor have been seized from individuals using the Section 59 power.
