## #YouSaid - What matters to you

**We have listened to you and the concerns you raised and the following:**

### Your Concern:

We understand that **drug use**, **drug dealing**, and the associated criminal activity are causing significant concern within the community.

### Our Response:

While we will continue to take firm and decisive action against those who are involved, we are equally committed to engaging with individuals affected by drug use. We aim to identify appropriate interventions and support services that can help them make positive changes.

**Your Concern:** **Anti-social behaviour** is a major concern for many residents on the beat.

**Our Response:** We are committed to identifying those responsible and addressing their behaviour through the Anti-Social Behaviour (ASB) incremental approach. This ensures proportionate and consistent action is taken, with the aim of reducing harm and improving community safety.

**Your Concern:** **Speeding and road safety** across the beat have been highlighted as key concerns by members of the community.

**Our Response:** With the Road Safety Partnership, the speed enforcement vehicle continues to be utilised to priority locations across the beat. This targeted approach aims to deter speeding, improve driver behaviour, and enhance overall road safety for all road users.

## #WeDid - What we are doing

### Community Engagement

PCSO Sal conducted a couple of beat surgeries on the 4th September at the Bowls club along side with **Jenny from Barnes Funeral Home** engaging with residents and listening to concerns.

The other beat surgery took place on the 18th September along with **PC SPENCER 379** who were joined by **GamCare**— A gambling support service to those over 18. (Pictures on next page)

## #WeDid—What we are doing continued



### Traffic Enforcement:

**PCSO Sal** has been proactive in monitoring areas where speeding and traffic-related issues have been a concern, both currently and historically. This includes overseeing speed calming measures in and around Sandy Lane, as well as ensuring compliance with weight restrictions in built-up residential areas such as Norfolk Drive.

### Anti-Social Behaviour:

#### Oxbow Close – Follow-Up Action

In partnership with **Sarah from Nottingham Community Housing**, we revisited a property where a previous **Anti-Social Behaviour** Contract had been breached due to cannabis use. Regrettably, further breaches have occurred. As a result, **Community Protection Warnings** (CPWs) have now been issued to both the occupant and their partner.

#### Kennelmore road– Enforcement visit

Working alongside **Katie from Melton Borough Council's Safer Communities Team**, we attended another property following reports of **cannabis use**. A CPW has also been issued to the occupier in response to these concerns. We remain committed to tackling **anti-social behaviour** and working collaboratively with our partners to ensure **residents feel safe and supported** in their communities.

**A Community Protection Warning** is a **formal notice** issued under the **Anti-Social Behaviour, Crime and Policing Act 2014**. It is given to individuals whose behaviour is having a **detrimental impact** on the local community. Continued breaches of this warning can result in **further enforcement action**, including **fines or criminal proceedings**. We use CPWs as part of a wider approach to tackling anti-social behaviour, working closely with partners to ensure communities remain safe and supported.

## Continued

### □ Crime & Patrols

We have been supporting our response teams with **live incidents** throughout September too and completing high visible patrols often on foot in some of our hotspot areas.

**Teamwork** with other beat officers from our neighbouring beats, assisting them with visiting vulnerable persons, dealing with suspects of criminal activity and ongoing neighbour disputes.

### □ Safeguarding & Welfare

Officers responded to **mental health-related welfare concerns**, including submitting a **safeguarding report** with the individual's consent.

### □ Station Duties

- The team also supported the **front enquiry office**, handling a wide range of public enquiries including criminal reports, intelligence sharing, and general queries.

### Fatal4 Road Safety Operation

A recent enforcement initiative targeted the **four main causes** of serious road traffic collisions, known as the **FATAL4**:

- Speeding
- Not wearing seat belts
- Using mobile phones while driving
- Drink and drug driving

The operation aimed to **deliver a robust, zero-tolerance** approach across the Leicestershire Force area. Unfortunately, a number of drivers and passengers were **found not wearing seat belts**, others were caught **using mobile phones**, and a few vehicles were deemed unsafe—requiring drivers to **change tyres on-site** before being allowed to continue their journey.

- We continue to deal with local issues such as Anti-social behaviour and safeguard vulnerable residents and cuckooing victims as and when we identify concerns.
- Our work is ongoing with local schools including engagement events.
- And lastly as 'Dedicated Neighbourhood Officers' we continue to work on and try find solutions with neighbour disputes. We also support our response colleagues and cover the front enquiry office too.
